

Financial Assistance Fund Information

We are pleased to offer financial assistance to families in need of support. Please read the following information before completing an application for financial assistance.

Who can apply for financial assistance at The Hundred Acre School at Heritage Museums & Gardens (HMG)?

- Any family who believes that they need financial assistance for their child to attend the school year program is welcome to apply.
- Applications are reviewed on a rolling basis.
 - O Please note: Applications for the upcoming school year are collected until March. Typically, the first awards are made in April.
 - o After March, please allow 4-6 weeks for processing.
- Only completed applications with all attachments will be reviewed. We consider each family's income and size, as well as extenuating circumstances so please be specific.
- We do not award full tuition; families receiving assistance typically provide at least 65%.
- All financial assistance is awarded after review and approval by a financial assistance fund committee.

<u>Is financial assistance guaranteed?</u>

- No, Heritage does not guarantee that all applications will receive financial assistance.
 - o If a family has received assistance before, we cannot guarantee support at the same level each year.
- Since we review applications on a rolling basis, we urge you to apply for financial assistance as soon as possible after receiving a school admission acceptance.
- Heritage has a maximum assistance amount to be awarded each school year.
 - o If funding is wholly used, we will keep your application on file to be reconsidered if funding becomes available.

Where does Heritage get the funds to award financial assistance?

• The funding for financial assistance is provided by generous donors and grants.

How do I apply for financial assistance?

- We urge families to get applications to the school by March 31 as the first review is often in early April.
- We request that you submit the application and documentation as one completed packet.
